PROMOTING EQUITY THROUGH HOUSING JUSTICE

Affordable housing is intrinsically linked to racial and social justice, serving as a cornerstone for equitable communities. Historical and ongoing discriminatory practices, such as redlining, segregation, and housing discrimination, have perpetuated racial disparities in housing access and affordability. These inequities have profound consequences, contributing to wealth disparities, neighborhood segregation, and limited economic opportunities for marginalized communities. According to the National Low Income Housing Coalition, people of color are disproportionately affected by housing insecurity, with Black and Hispanic households experiencing higher rates of housing cost burden and homelessness compared to white households. By advancing policies and initiatives prioritizing fair and equitable housing opportunities, we can work towards dismantling systemic barriers, promoting inclusive communities, and advancing racial and social justice.

WHAT THE DATA SAYS

RACIAL DIVERSITY

Tacoma is one of the most racially diverse cities in WA, where 41.5% of residents are people of color.

SEGREGATION

Residents identifying as Black experience the highest levels of segregation in Pierce County. ³



TACOMA DISPARITIES

Due to systemic factors,
Black households in
Tacoma have the lowest
median income
compared to all other
races/ethnicities.²

COST-BURDENED

Households led by a person of color have a higher rate of cost-burden than White households in Pierce County. ⁴

TACOMA'S HILLTOP

In 1970 census tract 617 in south Hilltop was 60.6% Black, by 2000 it was 35.4% Black, and by 2020 it was just 21.5% Black.⁵

DIVERSITY IS KEY

Residents of diverse neighborhoods are able to interact on a daily basis – they harbor less prejudice and racial stereotypes, can better handle diverse working environments, are more culturally sensitive, and have more expansive social networks.

EVICTIONS

Hilltop has the highest eviction risk in Tacoma, along with high eviction risks in South and East Tacoma.
